# HOME SHOW 2010 RULES AND REGULATIONS

## Setup Times:

May 19 – 10 am to 8 pm  
May 20 - 8 am to 5 pm

## Show Hours:

May 21 – 10 am to 6 pm  
May 22 – 10 am to 6 pm  
May 23 - 11 am to 5 pm

## Take Down Times:

May 23 -- 5 pm to 8 pm  
May 24 -- 7 am to 10 am

## IMPORTANT:

### **No take down of exhibits permitted prior to close of show on Sunday May 23rd!**

**Utilities:** Water, electric and drainage are the responsibility of the exhibitor. Order forms will be mailed April 2010 and should be returned to the convention Center prior to show set-up.

**Refunds:** No refunds will be granted after April 1, 2010.

**Exhibits:** Exhibitor agrees not to sublet or assign any portion of their space. No sign or courtesy card is to be displayed unless the supplier of equipment is a registered exhibitor.

**Booths:** The driving of nails, tacks, screws or use of any method of attaching material to walls ceilings or floors of convention center is prohibited. Exhibitors will be required to replace, repair or otherwise assume expense for any detachment or injury of premises caused by the exhibitor or his representative.

**Safety:** All exhibitors will be confined to working directly in exhibit area (not in aisles). There must be no construction or object blocking fire exits.

**Height Restrictions:** No exhibit may have dividers, drapes or any solid construction in excess of eight (8) feet in height. Exceptions may be requested in writing to the show management.

## **Exhibitor Badges:**

**Any person without an exhibitor badge will be required to pay the full admission price.**

Exhibitor badges are for exhibitors only and are non-transferable.

1 Booth – 4 Badges  
2 Booths – 6 Badges

3 Booths - 8 Badges  
4 or more Booths – 10 Badges
